Our Voices Really Matter

This article is intended to inspire you to use your voice to advocate for environmental improvements, including protections for our natural resources. We need all voices to speak up for our environment. When I am standing at the podium in front of the County's Planning Commission or the Board of Supervisors--ready to launch into public testimony in defense of our environment, natural resources and Huntley Meadows Park (HMP)--I am always feeling nervous about being on TV (Channel 16) or speaking in front of our elected officials. Then I take a moment to remind myself that nature has no voice at the decision-making table, so I must be that voice. That is enough to put me on solid ground and forget about being nervous. I realize that if I don't speak up, these issues may not be heard nor prioritized.

I want to share with you what I learned from recent experiences where I advocated for environmental improvements and natural resources protections, so that we can all be better prepared for future efforts like this. Since our elected officials actively seek input from citizens to inform their work, we can't sit back and not respond--we must provide that input. These requests for input are noted on officials' Facebook pages, at town hall meetings, or at public meetings for specific projects that occur throughout the year. Using our voices to remind decision-makers that our natural resources, our environment and its biodiversity (including our native wildlife) is key to us living a healthy life and that this is important to us, are key points to express as often as possible. **This really matters.**

The EMBARK Richmond Highway Project is a good example of a successful team effort to use our voices. Of course, no project like this is ever truly finished, and the EMBARK project is not completed. There are still ongoing process improvements that we hope to influence. But I want to reflect on lessons learned in the hope to inspire you to use your voice.

First, I want to thank Friends of Huntley Meadows Parks (FOHMP) members who attended EMBARK meetings and provided oral and written comments. At times, I admit, it was tough to rally the team to attend the 30+ meetings over the last two years. These monthly meetings seemed to go on and on and on. And while the process was going on, we wondered if our recommendations were being heard. Throughout, the team members held each other up, and we kept going. We continued to provide suggestions and recommendations and more at each public meeting. When I finally saw the proposed Plan Amendment language, I realized that the County staff and the EMBARK team had heard us. I am pleased to report that the EMBARK Plan Amendment approved by the Board of Supervisors on March 20, 2018 includes as part of its overarching vision (and throughout the document) the celebration of the natural and historic resources in the Lee and Mount Vernon Districts. These elements were not part of the original vision, nor were they as extensively included in earlier versions of the Comprehensive Plan for this area. This is an important accomplishment and the FOHMP and Friends of Historic Huntley (FOHH) team deserves a good pat on the back for this

Fairfax County's Two Champion Swamp Chestnut Oaks

These two Swamp Chestnut Oaks started life sometime between 1824-1844, according to Mike Knapp of the Fairfax County Urban Forestry Department. In 1982, the Fairfax County Big Tree Registry designated them Champion trees. They are "witness trees" growing amidst a changing landscape for two centuries. The stories they could tell!

Location: Northern boundary of Huntley Meadows Park near Lockheed Boulevard entrance


Species: *Quercus michauxii*

Circumference: Approximately 18 feet dbh (17 feet in 2003)

Age: 175-195

Condition: In 2004, Friends of Huntley Meadows Park and FOHH hired Bartlett and Growing Earth tree companies to trim away dead wood, inspect for disease and insect infestation and remove

surrounding understory saplings. A grant from the Virginia Department of Forestry made this possible.

work. There were other voices speaking with ours, and we thank them for standing strong with us. We also thank the County staff and the EMBARK team for hearing our recommendations and including them in the Plan Amendment.

Now, what have we learned from this complex process? Was it worth it? Yes, it was worth it. Was it hard work? Yes, it was hard work. Would we do it again? Yes, we would do it again. We know now that as development and re-development occurs in area Community Business Centers, environmental and historic resources are to be prioritized. Does this really matter? Yes, this **really matters**. These elements are the key reasons why many of us chose to live here; this is also a core reason for why future residents and businesses will come here in the future. And now, we know that for many years in the future, these guiding vision elements will be key drivers in the development and re-development of this area.

I look forward to hearing any comments you have on using our voices efforts and encourage each of you to use your voice to improve environmental conditions and natural resources protections, especially for HMP. We are lucky that the EMBARK Comprehensive Plan now includes this celebration of our historic and ecological resources. This is not the case in other parts of the County, although I hope that this model can be replicated in other areas. Our voices are still needed to advocate for this environmentally focused approach at a much more detailed level, one project at a time. Will you use your voice? I can tell you that your voice is needed out there advocating for a healthier environment, for balanced growth that protects natural resources for all of us. I also ask that you consider volunteering with your community’s homeowner’s association (HOA). If you live in the Mount Vernon District, ask your HOA to join the Mount Vernon Council of Citizens’ Associations (www.mycca.org) where they advocate for improved environmental conditions with development projects and generally for reduced environmental impact of these projects. Or, if you live in the Lee District, consider asking your HOA to join the Lee District Land Use Committee (email: leedis-tract@fairfaxcounty.gov) or the Lee District Association of Citizens’ Associations (www.ldacova.org) These groups are actively engaged in working to reduce the environmental impact of development projects and to improve environmental conditions for all of us.

I look forward to seeing you and hearing your voice out there!
