Message from Park Manager Karen Sheffield

I recently returned from a trip to the Himalayan region of India to attempt to see wild snow leopards. Five minutes into our first meal, news came that a snow leopard had just crossed the road nearby. Everyone abandoned lunch and grabbed backpacks – since we hadn't even gotten into our rooms yet – and went down the road. We spent the next several hours sitting on the rough, rocky, high desert landscape getting glimpses of a now resting snow leopard 150 feet away. The snow leopard would give us views as it would occasionally turn, stretch and reposition amongst the rocks. Near the day's end, we watched the cat walk up and over the mountain. It was, and still is, surreal to have this experience, one that I doubted would ever happen.

We returned to our small lodge located in a village consisting of five families. During my stay, I got a chance to know some of the families who live in the heart of snow leopard territory. One charming woman, just a few years older than I am, is so happy to have visitors during the slow winter season. Most of all, she can't believe that so many people come from all over the world to her village just to see a cat.

This reminded me of an Australian woman I met during a previous trip in the U.S. What did she really want to see more than anything? A squirrel. I let her know her chances were good, and it was fun to be around her every time she delighted in squirrel sightings. It helps remind me that wonderful things are really all around us.

Finding enchantment and awe in the everyday lifts our spirits and nourishes our souls. I hope during this challenging time you find something that enchants you each day, and you can surround yourself with things that enrich your life.

Neighborhood wildlife sightings (foxes, groundhogs, birds) and warm showers from the tap are my two of my daily enchantments!

peace. Nature is in our parks and natural areas, and in most cases, it is very close by to where each of us is following the Governor's stay-at-home orders. You can experience nature directly via the view out of your window (from your stay-at-home office), or through your afternoon exercise walk next to the trees planted along the streetscape in your neighborhood, or even by observing the potted plant on your front stoop where bees are flying around its blooms.

During this difficult period, we know that Fairfax County is experiencing adverse impacts to the county budget. The coronavirus pandemic also poses a financial risk to our parks, because it affects funding of the Fairfax County Park Authority both in terms of its revenue streams and the county budget. We can all agree there is a need for urgent short term spending to address the health and economic impacts of the coronavirus crisis. However, when planning future budgets, we need to remember and advocate for the importance of our parks and natural areas, which need adequate budgets to manage them - especially evident during crisis periods.

All of our parks need our attention, especially during this challenging time. Our parks and natural areas fuel our health and well-being. We need to be vigilant in making sure that these areas remain protected and cared for. Some may take advantage of these times to expand encroachment or harvest natural resources illegally from our parks, or to push through policies or actions that are not favorable for our parks and natural resources. Many Park visitors, including FOHMP members, are paying close attention, not just to HMP during these times but to all parks and natural areas throughout Fairfax County. Won't you join us?

We all look forward to better days, when the COVID-19 pandemic will be behind us. In the meantime, please do all you can to stay safe and healthy. Soaking in the beauty of the natural world around us will help us stay grounded and contribute greatly to our well-being on numerous levels. Take the time during these stay-at-home periods to add more native plants (including native trees) to your yard. These actions will improve our natural world, for us and for the native wildlife that depend on us. Don't forget to follow the physical distancing recommendations, staying six feet or more away from those not in your household. After this public health emergency is over, I look forward to seeing you again on the trails of HMP.
